#### **BY-LAWS**

# A. Douglas Smith, Jr., Masonic Research Lodge N°. 1949 A.F.& A.M. Alexandria, Virginia

#### ARTICLE I

The stated communications of this Lodge shall be held at the Masonic Temple as designated by the Lodge or the Worshipful Master in Virginia on the fifth Saturday of those months having five Saturdays at 10:00 A.M. o'clock, with the exception of November and December, and an annual meeting in December which shall be held on the third Saturday at 10:00 AM.

#### **ARTICLE II**

Every member of this Lodge except the Treasurer, Secretary. and Tiler on January 1st of each year shall be charged by the Secretary with the sum of Fifteen Dollars (\$15.00) yearly dues.

### ARTICLE III (Not Applicable to Research Lodges)

### ARTICLE IV

The Treasurer shall receive an annual compensation of Seventy-five Dollars, payable in quarterly installments of \$18.75

#### ARTICLE V

The Secretary shall receive an annual compensation of One Hundred Fifty Dollars, payable in quarterly installments of \$37.50

#### ARTICLE VI

The Tiler, or Acting Tiler, shall receive a compensation of N/A Dollars for each communication he attends in that capacity.

#### ARTICLE VII

The 3 Trustees, who shall be recommended by the Lodge and appointed by the Court having jurisdiction, shall at each annual Stated Communication in December make a report of the investment of all funds and condition of property entrusted to their care.

#### ARTICLE VIII

Any amendment proposed to these by-laws must be submitted in writing at a stated communication, lie over the required four weeks, the membership be notified, and shall require a simple majority affirmative vote of the members present for its adoption.

#### ARTICLE IX

## **Corresponding Members**

- 1. Petitions for Corresponding Membership in A. Douglas Smith, Jr., Lodge of Research No. 1949. A.F.& AM., shall be accepted only from members of Lodges in Grand Jurisdictions recognized by the Grand Lodge of Virginia.
- Corresponding Members will not be carried on the Grand Lodge roster for A. Douglas Smith, Jr., Lodge of Research No. 1949
  members.
- 3. Corresponding Members shall not have a vote in this Lodge and shall be subject to the same rules of admittance to a Communication of this Lodge as any other visitor as covered by the Laws of the Grand Lodge of Virginia.
- 4. Petitions for Corresponding membership must be endorsed by two (2) Master Masons who are members of Lodges in Jurisdictions recognized by the Grand Lodge of Virginia.
- 5. Petitions for Corresponding Membership shall be read and lie over until the next Stated Communication to be balloted on.
- 6. Dues for Corresponding Members shall be five dollars (\$5.00) per year. payable with the petition and on January 1st of each year.
- 7. Corresponding Members who are two (2) years in arrears in their annual dues shall be dropped from membership.
- 8. Corresponding Members shall receive copies of all communications and publications of A. Douglas Smith, Jr., Lodge of Research No. 1949. A.F.& A.M.

#### CERTIFICATION
